Volunteer Release and Disclosure Form for Criminal History Record Search

Disclosure: Criminal History and National Sexual Offender (CH&NSO) Background checks are required for all existing YMCA of Greater Michiana volunteers, staff employees hired, transfered, promoted, reclassified or reassigned, or for the security of YMCA of Greater Michiana resources. If the CH&NSO background check reveals a criminal conviction or other information relevant to that position, you may be disqualified from holding that position.

Authorization: I understand that I am required to furnish the attached information for the YMCA of Greater Michiana's use in determining my continuing qualifications for my current position at the YMCA of Greater Michiana. I authorize my current employer, previous employers, and any law enforcement agency to release tot eh YMCA of Greater Michiana any information about me which said current or previous employer or law enforcement agency may have in its possession. Unless already prohibited by law, this includes but is not limited to any data or materials involving disciplinary matters which the employer has sealed. It also includes any data or materials involving disciplinary matters which the employer has promised to withhold pursuant to any agreement to which I am a party. I agree that a photocopy of this Authorization may be accepted by any law enforcement agency or by my current or former employer in the same manner as the original. I hereby expressly waive any requirement that I be provided prior or contemporaneous notice (either oral or written) of the agency's or employer's release of information or documents about me to the YMCA of Greater Michiana.

Additional, I give consent for the YMCA of Greater Michiana to run an annual CH&NSO background check if I continue to volunteer for more than 1 year.

I further understand that the extent the YMCA of Greater Michiana is prohibited by law from sharing confidential reports about me that it receives either from a law enforcement agency or from a current or former employer, I am entitled to receive summaries of the contents of the reports upon request.

Release: I hereby release, discharge and exonerate any person, agency or entity supplying information and documents about me to the YMCA of Greater Michiana pursuant to the above Authorization from any and all liability of every nature and kind arising out of the furnishing of such information and documents.

I further understand and agree that any misrepresentation, falsification, or omission of facts by me may constitute good cause for corrective action, up to and including my disqualification, release or dismissal from YMCA of Greater Michiana's employment. I also understand and agree that my involvement with the YMCA of Greater Michiana is conditioned upon the YMCA of Greater Michiana's determination that the results of this background check are satisfactory. I further agree and understand that future criminal behavior by me may be considered in a review of involvement status by the YMCA of Greater Michiana.

YMCA of Greater Michiana Code of Conduct

- Resolve conflicts in a respectful, honest and caring manner; never resort to physical contact, verbal abuse, or threatening gestures.
- Speak in respectful tones and refrain from the use of vulgar/derogatory comments or profanity.
- Respect others by refraining from intimate behavior in public; abstain from contact of a sexual nature.
- Respect the property of others; never engage in theft or destruction.
- Create a safe, caring environment; never carry firearms or weapons on YMCA premises.
- Participate in programs to build a healthy spirit, mind, and body. For participant's safety, never engage in the use, sale, dispense, possession, or appear to be under the influence of illegal drugs, narcotics, or the unsanctioned use of alcohol on YMCA premises. This includes marijuana.
- Prohibit anyone convicted of a crime involving child abuse or sexual abuse, or anyone listed on the National Sex Offender List to participate under my membership.
- Abstain from the use of tobacco products, including vaping, in the facility or on the property.
